Fisheries Management & Legislative Report

Bluefin Tuna

There are two notices below that were sent out about the upcoming hearings on new management measures for bluefin tuna. The first notice is the update on the meeting in Toms River. The original press release had an earlier meeting date but contained more information about what is going on. Please read both notices. In the original notice the comment period ends on July 31 but the meeting in Toms River has been changed to July 30. If you are coming to the July 30 meeting you can hand in your comments then. I will be asking for an extension to the comment period. At this time JCAA does not have a Highly Migratory Species Chairman or committee. If you are at all interested in sharks, tuna, swordfish or other highly migratory species, let me know if you want to volunteer as a member or a chair. If some of the clubs want to have a meeting on this proposal, let me or Mark Taylor know.

Striped Bass Update

I do not have any new information since I wrote the article for the June newspaper so I have included it below. New information for the August 6th -8th ASMFC Summer Meeting will be posted at the ASMFC web page on July 27. The supplemental materials should be posted by August 1. I will try to send an alert when they are posted. The meeting will be on August 8 beginning at 8:30. There will be public hearings after the August meeting. JCAA does not have a position at this time and no general meeting is scheduled until September 24th. I am asking for 3 public hearings in New Jersey. If these hearings are scheduled before September 24, JCAA might need a

special striped bass meeting to determine our position. The comment period will probably last until October since the annual meeting is not until the last week in October. I will keep you posted.

Striped Bass Update

As you can see in the press release below, there is a new striped bass benchmark stock assessment. There was much discussion about how to proceed and it was decided to do an addendum first. In August there will be further discussion about an amendment to the striped bass bill which will consider many of the states' concerns.

The addendum will look at whether we do another reduction of the recreational striped bass catch. There will also be consideration of what should be done on the commercial side. Some states proposed doing nothing since they didn't think they were the problem. They forgot to mention the millions of pounds of fish that are poached with many court cases to prove this is happening.

I will be waiting to see how the board will deal with recreational discards since that makes up 52% of recreational morality. The board cannot ignore this. I find it interesting that New York never discusses their poaching problem even though those of us who fish in Raritan Bay can attest to this problem. New Jersey and Maryland have pursued poachers but it is hard for us to do that for other states. New York needs to get its house in order.


I found it extremely interesting that the 2018 preliminary information about the catch is not included in the information being disseminated. I recommended that we use the 2018 data since it is the most current and it should be finalized before the August meeting. The catch figure is a 25% reduction. It is more than the 17% reduction being considered for the addendum. The states that are looking to be the most conservative are opposed since they said it wasn't included in the benchmark and want to ignore it. I asked them not to. If we have firm data for 2018. it should be included in any discussion about an addendum. I got little support for this approach and I will bring it up again in August and insist that it be included. Good fisheries management uses the best and the most current data for decisions.

Atlantic Striped Bass Benchmark Stock Assessment Finds Resource Overfished and Overfishing Occurring

Board Initiates Addendum to Reduce Total Fishing Mortality

ASMFC Press Release, May 1 2019

Arlington, VA – The 2018 Atlantic Striped Bass Benchmark Stock Assessment indicates the resource is overfished and experiencing overfishing relative to the updated reference points defined in assessment. Female spawning stock biomass (SSB) was estimated at 151 million pounds, below the SSB threshold of 202 million pounds. Despite recent declines in SSB, the assessment indicated the stock is still significantly above the SSB levels observed during the moratorium in the mid-1980s. Total fishing mortality (F) was estimated at 0.31, above the F threshold of 0.24. The benchmark assessment and its single-stock statistical catch-at-age model endorsed by the Peer Review Panel and accepted by the Atlantic Striped Bass Management Board (Board) for management use.



Based on these findings and the tripping of Amendment 6's reference point management triggers relating to F and SSB thresholds (e.g., F in 2017 is above the threshold level and SSB is below the threshold level), the Board initiated the development of a Draft Addendum to consider measures aimed to reduce F to the target level. The Technical Committee estimates it would require roughly a 17% reduction in total removals (commercial and recreational harvest, including dead releases) to reduce F to the target in 2020 relative to 2017 levels. The Draft Addendum

will explore a range of management options, including minimum size and slot size limits for the recreational fishery in the Chesapeake Bay and along the coast, as well as a coastwide circle hook requirement when fishing with bait. The Board also provided guidance on how to apply the necessary reductions to both the commercial and recreational sectors. The Draft Addendum will be presented to the Board for its consideration and approval for public comment in August. If approved, it will be released for public comment, with the Board considering its final approval in October for implementation in 2020. Additionally, the Board postponed a motion to initiate the development of an Amendment until its next meeting in August.

Atlantic striped bass experienced a period of strong recruitment (estimated as number of age-1 fish) from 1994-2004, followed by a period of lower recruitment from 2005-2011 (although not as low as the early 1980s, when the stock was considered collapsed). This period of low recruitment contributed to the decline in SSB in recent years. Recruitment was high in 2012, 2015, and 2016 (corresponding to strong 2011, 2014, and 2015 year classes), but recruitment estimates were below the long-term average in 2013, 2014, and 2017. Recruitment in 2017 was estimated at 108.8 million age-1 fish, below the time series average of 140.9 million fish.

Toms River, NJ meeting to take place July 30, 2019 at the Ocean County Library 101 Washington Street, Toms River NJ 08753 at 5-8PM.

NOAA Fisheries has updated the scoping meetings schedule for actions evaluating possible revisions to measures implemented under the 2006 Consolidated Atlantic Highly Migratory Species (HMS) Fisheries Management Plan.

The meeting in Toms River, NJ, which will feature a discussion of bluefin tuna management measures, will now take place on July 30, 2019 at 5–8 p.m.

The public process for the actions listed below begins with scoping to determine the range of issues for each action. Notices announcing our intent to prepare an environmental analysis under the National Environmental Policy Act and the availability of an issues and options paper for each action were announced separately.

*The July 30, 2019 meeting in Toms River, NJ may be scheduled along with a public hearing for a proposed rule to modify pelagic longline bluefin tuna areabased and weak hook management measures. For further information, watch for an upcoming Federal Register notice announcing the proposed rule public hearing schedule.

Amendment 13 to the 2006 Consolidated HMS Fishery Management Plan: Bluefin Management Measures

Notice by NOAA, 05/21/2019

AGENCY:

National Marine Fisheries Service (NMFS), National Oceanic and Atmospheric Administration (NOAA), Commerce.

ACTION:

Notice of intent (NOI) to prepare an environmental impact analysis; notice of availability of issues and options paper; request for comments.

SUMMARY:

NMFS announces its intent to prepare an environmental impact analysis under the National Environmental Policy Act (NEPA), availability of the Issues and Options Paper for Amendment 13 to the 2006 Consolidated Highly Migratory Species (HMS) Fishery Management Plan (FMP) (Issues and Options Paper). This notice announces the start of a public process for determining the scope of significant issues related to the management of Atlantic bluefin tuna (bluefin), and addressing issues identified by considering modification of bluefin regulations. The catalysts for beginning this regulatory process are the release of the Draft Three-Year Review of the IBQ Program (Three-Year Review), recent changes in the bluefin fishery, and advice and input from the HMS Advisory Panel and the public.

The environmental impact analysis will include an assessment of the potential effects of alternative measures for management of bluefin under the 2006 Consolidated Atlantic Highly Migratory Species Fishery Management Plan (2006 Consolidated HMS FMP). The subjects in the Issues and Options Paper include refining the Individual Bluefin Quota (IBQ) Program, reassessing allocation of the bluefin quota and subquota, including the potential elimination or phasing out of the Purse Seine category, and other regulatory provisions regarding directed fisheries and incidental pelagic longline fisheries. The scoping process and environmental impact analysis would determine whether existing management measures are the best means of achieving current management objectives and providing flexibility to adapt to variability in the future, consistent with the 2006 Consolidated HMS FMP, the Magnuson-Stevens Fishery Conservation and Management (Magnuson-Stevens Act), the Atlantic Tunas Convention Act (ATCA), and other relevant Federal laws. NMFS will use the scoping process and the draft impact analysis environmental to consider development of Amendment 13 to the 2006 Consolidated HMS FMP, if warranted.

NMFS is requesting comments on this NOI and the management options described in the Issues and Options Paper, and other potential regulatory provisions regarding the bluefin directed fisheries and incidental pelagic longline fishery that would meet the purpose and need for this action. NMFS will hold public scoping meetings and a webinar to gather comment on these measures and potential management options. The time and location details of the scoping meetings and webinar will be announced in a separate Federal Register notice. NMFS will also present the Issues and Options Paper at the HMS Advisory Panel Meeting on May 22, 2019 (link).

JCAA New Format Fluke Tournament - August 16th, 17th and 18th

The Jersey Coast Anglers Association is pleased to announce that we will be running a second fluke tournament this summer on August 16th, 17th and 18th. We are going to try an exciting new format and see how much interest it generates. For seven years in a row, we have had bad weather or a bad weather forecast on the day of our tournament. Therefore, this tournament will run for three days with hope that we will have good weather on at least one day. We realize that not everyone can fish two or three days, so to be fair to everyone, each boat will be limited to fishing only one day. However, each entrant will be able to choose the day they fish. The other major change is that the 1st through 5th place prizes will be based on the total weight of each entrant's three largest fluke. This will take some of the luck factor out of the tournament and we are also limiting the number of anglers to 4 per boat to keep it a level playing field. Based on a minimum of 250 boats, 1st place will be \$5000, 2nd place \$2500, 3rd place \$1500 and there will be gift certificates from our sponsors for 4th and 5th place. Additionally, there will be a \$1000 prize for the largest fluke caught in the tournament. We will also have \$50 and \$100 three fluke Calcuttas, \$50 and \$100 single fluke Calcuttas and even a \$50 single seabass Calcutta.

This tournament is being run on short notice so there will only be four weigh-in stations this year, located in the central part of our state. The weigh-in stations will be Fishermen's Den in Belmar, Capt. Bills Landing Marina in Manasquan, Creekside Outfitters in Waretown and Fisherman's Headquarters in Ship Bottom. However, if this new format works, we will add more weigh-in stations to the north and south next year. We hope to take the best features of both of our tournaments and combine them into one really good tournament next year.

The awards ceremony and Country Style Barbeque will be held at the Brick Athletic League Building from 5-9 PM on August 18th. Barbequed chicken, pulled pork, sausage & peppers, baked beans, corn on the cob, coleslaw, macaroni salad, soda and water will be served and you can BYOB as well. We will have a 50/50 and live entertainment will be provided by Ken and the Escorts!

Entry fee per boat (up to 4 anglers) is \$125 by 8/9 or \$150 after 8/9. The entry fee includes two admissions to the Awards Ceremony/BBQ but additional tickets may be purchased for \$25 each. Public Access Bill Update

With the urging of many fishing and environmental organizations, Governor Murphy signed the Public Beach Access Bill on May 3, 2019. This law becomes effective on July 3, 2019.

The Public Access bill codifies the Public Trust Doctrine into law. This Doctrine states that the tidal waters are held in trust by our State for the benefit of the public. The bill confirms the public's longstanding right to use our state's tidal waters and its adjacent shorelines. It also provides direction to the New Jersey Department of Environmental Protection (NJDEP) on how to protect and enhance public access when permitting development and approving publicly funded projects. The NJDEP is now directed to make all tidal waters and their shorelines available to the public and remove physical and other impediments that limit this access.

The passage of this bill was the culmination of a long struggle that began in 2015. The Hackensack Riverkeeper won an appeal of the NJ DEP's Public Access Proposal since it would have stripped back protections of the Public Trust Doctrine. Shortly after this appeal, Senator Bob Smith, head of the Senate's Environmental and Energy Committee, convened a task force in 2016 to help our legislature develop provisions for a new Public Trust Doctrine that would codify and strengthen our state's obligations to provide public access to its beaches and waterways. task force was comprised of various organizations and led by the American Littoral Society and the NY/NJ Baykeeper. Approximately 40 to 50 people attended these task force meetings that were held in Trenton. I attended three of them and I can attest that these meetings sometimes became heated with individuals advancing their special interests that collided with the interests of other organizations. After a number of meetings and hearings with Senator Bob Smith, language for this bill (A) 4221 and (S) 1074 was finally developed and acceptable for passage by our legislature during

March of this year and passed on to the Governor for his signature.

In the past, municipalities have restricted public access with restrictive parking measures, vacating street ends and non-maintenance of necessary dune/bulkhead walkways that are needed to access the water's edge. In short, many municipalities passed ordinances with the focus of keeping anglers off "their" beaches. This type of mindset will be a challenge to change even with this new access law in place.

A meeting was held on June 14th at the American Littoral Society's office in Sandy Hook and chaired by Tim Dillingham with representatives from various fishing and environmental organizations. The purpose of this meeting was to unite members of these organizations into a new coalition to ensure that provisions of this new bill are properly managed and enforced by the NJDEP. This will **not** be an easy task. I represented the JCAA, New Jersey Outdoor Alliance (NJOA) and the Salt Water Anglers of Bergen County. This meeting started at 10:00 a.m. and ended at noon. The following are some of the major points that were raised at this meeting:

- Identify and inventory those municipalities where access is restricted and is in clear violation of the new law. George Browne of the JCAA will lead this effort.
- When tax monies are spent on various public projects, new or improved access must be provided.
- When new building permits are initiated for shore/waterway locations, municipalities must have public access included in them.
- This law is new and the details of it have to be developed as in a model ordinance so that they are easy to understand for municipalities to follow and also include in their town's Master Plans.
- The public also needs to understand the rights it has for access under this new law so that it can report any violations they experience.
- When violations occur, who in the NJDEP will be the contact person(s) for taking reports and initiating corrective measures? Enforcement is key to the success of this new law.

Tim Dillingham agreed to develop a summary of this meeting with input from the coalition members.

When this summary is completed, he will send it to NJDEP Commissioner Catherine R. McCabe for her review and discussion.

This new law for public access will not make changes overnight to the restrictive measures anglers have endured for many years blocking their access or limiting access to beaches. However, I do believe in time we will see better public access to our beaches and waterways. I will keep you updated as changes occur.

Your Sunscreen May Kill Coral Reefs. What Should You Do?

Coral reefs are the most diverse marine ecosystems in the world. They have existed for over 400 million years and give shelter to thousands of animal species.

Today, coral reefs are dying at an alarming rate. Ongoing climate change is responsible for the death of approximately 50 percent of the world coral in the last 30 years.

According to scientists, it's not only the climate change to cause coral death. Regular sunscreen can induce the same <u>bleaching response in corals</u>.

The extinction of corals can have devastating global-scale effects, but we can all contribute to preserving our reefs by swapping regular sunscreen with a reef-safe sunblock.

How Does Regular Sunscreen Affect Coral Reefs?

Regular sunscreens utilize two key ingredients to protect you from sunburns and potentially from skin cancer, oxybenzone, and octinoxate.

These synthetic molecules are present in almost all chemical sunscreens, and they are highly toxic for corals and marine species. According to research, when corals absorb these compounds, they expel their life-giving algae, a phenomenon known as coral bleaching.

Oxybenzone, above all, is so toxic that a single drop of it in over 600,000 gallons of water is enough to endanger these marine organisms.

With an estimated 14,000 tons of sunscreen being washed into the ocean each year, the large-scale consequences can be disastrous if we don't decide to use reef-safe products.

What Is Reef-Safe Sunscreen?

Reef-safe sunscreen, also known as mineral sunblock, is a type of sunscreen that utilizes particles of zinc oxide or titanium dioxide that act as a barrier between your skin and the harmful rays.

However, not all mineral sunscreens are reefsafe. Studies have shown that corals can ingest nanosize particles of these compounds, which could also lead to coral bleaching.

Reef-safe sunscreens are those mineral sunscreens that contain non-nanoparticles (particles with a size over 100 nanometers) of zinc oxide or titanium dioxide.

How Can You Help Protect Coral Reefs?

It is a fact that regular sunscreen is harming coral reefs. Small changes in your choices and behavior can contribute to preserving these fragile ecosystems, though. Here are a few things you can do.

1 - Use Reef-Safe Sunscreen

Your first reef-savvy decision — especially when vacationing in reef areas — should be to use a mineral sunscreen containing non-nanoparticles of zinc oxide or titanium dioxide. Some popular beach destinations have even banned the use of chemical sunscreens, so a reef-safe choice might be your only choice anyway.

2 - Avoid Aerosol Sunscreens

Even if labeled as mineral, most aerosol sunscreens contain nano-sized particles, which are harmful to corals and other marine species.

3 - Use Less Sunscreen Overall

Beachwear with embedded UV protection factors, such as shirts, shorts, and sunhats can limit the use of sunscreen with up to 90 percent. UV-proof beach tents and umbrellas can also help you limit the use of sunscreen.

Coral reefs are threatened with extinction, and along with them, the entire marine biodiversity. Regular sunscreen is one of the factors that lead to coral bleaching and potentially coral death. A small change in behavior and more environmentally-savvy decisions when choosing your sunblock is the least you can do to limit this potentially catastrophic phenomenon and preserve the beauty of our oceans.
