Important Reminder: Saltwater Registry and Personal Floatation Device Regulation

It's a new year and it's time to register or renew your Saltwater Recreational Registry. You may do so by clicking on the link below. Why register? It's the law and it's for Free! Without being registered, you could be fined or you could be disqualified for a tournament or record catch. Also, it's possible that quotas for various species could be set by the number of fishermen in each state or region. Registering is the best way for our state to keep track of how many fishermen we have so that we don't get shortchanged.

As most of you probably know by now, New Jersey has a relatively new regulation pertaining to the wearing of personal flotation devices which was set by administrative code as shown below:

N.J.A.C. 13:82-1.4 Personal flotation devices

(f) No owner or operator of a recreational vessel less than 26 feet, including rowboats, canoes, kayaks, and stand-up paddleboards shall permit its operation between November 1st and May 1st, unless each person on board such vessel is wearing a securely fastened United States Coast Guard-approved wearable personal flotation device of an appropriate size while such vessel is underway. A person inside the cabin of a cabin vessel shall be exempt from this requirement.

However, there were a couple questions that came up regarding this law. One was how is “underway” defined. Many people believe that to mean when the boat is under engine power or sail. That is not the case though, as underway is defined as a vessel not at anchor, aground or made fast to land. That means that a boat drifting or even being held in place by a trolling motor is considered to be under way.

Another question was how “recreational vessel” is defined and whether or not the regulation applies to the for-hire sector. “Recreational vessel” is defined as a vessel being manufactured or operated primarily for pleasure or leased, rented or chartered for another for the latter’s pleasure. So yes, the new law does apply to the for-hire fleet as well.

The last question I received was whether or not this new law applies to federal waters as well. The answer is no; it does not. It is a NJ regulation which applies to all waters within our state. However, there are separate regulations in Federal waters. One in particular states that “On a vessel that is underway, children under 13 years of age must wear an appropriate U.S. Coast Guard-approved life jacket unless they are: Below deck or Within an enclosed cabin”.

President's Report

As president this year, my objective is to enhance angler participation within the JCAA and encourage greater involvement in fishery management initiatives. While I acknowledge that achieving this goal presents considerable challenges, I am convinced it is vital to the long-term success of both the JCAA and our fisheries. I am fully committed to dedicating my efforts toward this purpose and anticipating support from several members as we work together toward this objective.

As we enter a new year, it is reasonable to anticipate developments in fisheries management. While changes do occur annually, they do not always align with the priorities of the recreational fishing community seeking improved access to preferred species. It is important to recognize that the fisheries management process is not without flaws, an admission that has been made by relevant authorities, though perhaps not frequently enough. This year, one of my objectives is to promote education and encourage greater engagement among recreational anglers so they

can contribute meaningfully to the decision-making process.

A good starting point is to access information directly from its source. Many anglers do not know how to do this or realize they can participate by sharing their opinions after reviewing and understanding the material. We should not depend solely on a small group of devoted anglers and outdoor writers. I am planning to organize some Zoom meetings throughout the year to keep recreational anglers informed. The first session will offer a brief overview of fishery management processes and where to find more detailed information. These meetings will last about 90 minutes each to ensure the content is not overwhelming and can be digested over time. My goal is for these sessions to be informative, educational and not discouraging. Stay tuned as I plan to include visual slides and invite others to contribute as well. I hope to begin in a few months. It is important for all anglers to get involved and stay informed, so our recreational community can have a stronger voice in the decision-making process and possibly make a difference.

It is essential for every angler to visit the NJDEP – NJ Fish & Wildlife website. The site provides comprehensive and regularly updated information, making it a valuable resource for saltwater fishing enthusiasts. Anglers are encouraged to review all available materials related to saltwater fishing, and to register or renew their registration for the **2026 NJ Saltwater Recreational Registry** at [this link](#) — a process that must be completed annually. Registration is free of charge; however, participation ensures accurate counts of saltwater anglers in New Jersey. These data are critical for determining eligibility and allocation of federal funding necessary to support future fisheries research and management initiatives.

With the arrival of fishing flea market season, opportunities abound for those seeking quality tackle and equipment at competitive prices. I encourage you to attend these events and support the organizations that dedicate significant effort to making them possible. Whether you are interested in acquiring new or used tackle, these markets present valuable options.

The show season is underway, with the New Jersey Shows approaching rapidly. JCAA will have booths featured at both the **Atlantic City Boat Show** (February 25th to March 1st) and the **Saltwater Fishing Expo** (March 13th-15th). We appreciate those who have already committed their time as volunteers for JCAA during these events; however, we are still seeking additional volunteers to ensure our booth is fully

staffed. Maintaining a strong presence at these shows is essential for our organization to effectively connect with the recreational angling community.

Kindly respond as soon as possible as volunteer names must be submitted several weeks in advance to organize complimentary passes. Volunteers are welcome to explore other event vendors before or after their scheduled time at our booth as an added benefit.

Ed Potosnak Nominated for DEP Commissioner

Governor-elect Sherrill Nominates Ed Potosnak to be Commissioner of the NJ DEP

What Has Happened with the Recreational Fishing Community Working Together

In the 80's the recreational community was working together for the rebuilding of striped bass stocks. The community included catch and release fishermen, party and charter boats, subsistence fishermen and people who wanted to take home a fish to eat. The community spoke with one voice and made that voice heard. As soon as the stocks were rebuilt and the fishery was open, some of the members of a certain part of this community looked at striped bass as only a species for catch and release. When the stocks were at an all-time high and when New York went to open up the fishery to 2 fish at 28 inches like most of the rest of the coast, the catch and release community fought against that plan. When New York planned to give the party and charter boats 2 fish per angler, some of the catch and release community fought that plan as well. They also fought against allowing subsistence and recreational anglers to take a fish home to eat. They won that battle because they were the loudest voices at the table. This

fracture in the recreational community led to extremes across every issue. The whole atmosphere has become a “we’re right, you’re wrong” mentality. The lack of cooperation means none of us have the impact on the decisions ASMFC makes while we are fighting with each other. After JCAA and its member clubs in New Jersey succeeded in making the Striped Bass Gamefish bill (no-sale) in NJ, JCAA spent a lot of time and money trying to help other states in passing their own bill. JCAA, with the help of ASA organized coastwide meetings for those organizations in other states. We were instrumental in the formation of the NY, Virginia and Maryland CCAs and then working with them and National CCA and the existing CCAs of Maine and Connecticut to work on making striped bass a coast wide gamefish. We were a united community with a single goal.

Today is just the opposite. A perfect example is the American Guides Association. They have spent a lot of time attacking New Jersey's bonus tag program saying we should not have the extra fish we got converting the commercial fishery. New Jersey's recreational anglers took a commercial quota and turned it into a supplement for the recreational community. But what we really did was establish a quota that made sure there would never be a commercial striped bass fishery in New Jersey again. New Jersey's anglers have had the option to harvest that quota and over the years we have harvested only a small part of that quota. If that quota had been a commercial quota, we would have lost millions of pounds of striped bass to a commercial harvest that remains protected and keeps down the illegal commercial fishery harvest that happens in other states that do allow a commercial fishery in their state. Look at the millions of pounds landed illegal in Maryland that happen by just a couple of commercial fishermen. These same groups have suddenly become quiet about striped bass gamefish along the whole East coast. Because they failed in making striped bass a game fish in their states, some of these groups started attacking subsistence anglers and those who want to take home a fish to eat. Instead of going after the commercial fishermen in their states, they focus the attention on other recreational anglers who want to take home a fish to eat. That is where we are today.

It would be interesting to put all this energy into coastwide game fish status. Remember, because of the effort that was made with the help of ASA, CCA and other groups working with local groups, an executive order was signed by President Bush that if the EEZ was

ever opened, it would be open only for recreational fishing. We need to get back to working as a united community, working to protect every facet of our community, not just for your own interests. I am looking forward to hearing the guides association taking on the commercial fishermen in their own states and doing what we did in New Jersey. If you are not protecting your own state, leave New Jersey alone because we accomplished what you could not.

Striped Bass and Hatcheries

I got an email from one of the club reps asking if we can raise striped bass at hatcheries. I explained to him that was done during the 80's in several hatcheries in Maryland, Virginia and North Carolina. I was able to find some documents about the hatchery in New York and the proposed North Carolina plan to bring back striped bass in the Cape Fear River. They released 220,000 8-inch striped bass into the river. I also came across a document from New York DEP in 1973 that discusses the reasons why Indian Point Power Plant should release hatchery raised striped bass into the Hudson River. That document can be found at [this link](#). It contains a good deal of information about why the fish should be raised and released into the river. If you have a problem with the link email me and I will send it to you.

When I started attending ASMFC Striped Bass Board meetings, I heard about the stocking programs in Virginia, Maryland, and North Carolina which were designed to help rebuild the stocks. They were putting in a lot of fish, each of which was tagged with a magnetic tag that we could wand. We would not even have to catch the fish, just wand them where they spawned. That would tell us how many were on the spawning grounds. These fish were raised to a 2-inch size limit before they were released which increased the opportunity of survival. After many years of attending scientific meetings, I have learned the impact of chemicals on the larva, eggs and in the early stages of development. There were even studies done on rats showing chemicals in their water at certain stages of development would create specific diseases. It would also have an impact on their sexuality as we have been finding out with the research on endocrine disruptors. These fish were raised in a sterile environment until they were through those early stages of development

and did better than fish exposed throughout those early stages. As these fish matured, they played an important role in spawning season. People were surprised how many of the tagged fish were actually spawning and we began to see good year classes.

Raising striped bass in hatcheries is expensive. As soon as the stock began recovering, the hatcheries were closed except for the New York hatchery. Fisheries managers have always been skeptical of using hatcheries in salt water. There has been little discussion about striped bass. But all we have to do is look at what hatcheries have done to bring back the stock of red drum in the gulf and in Florida. On the West Coast there would not be salmon fishing without hatcheries due to all the dams, water drained for irrigation and drinking water and other habitat issues that we have created. That is even true in the more pristine areas of Alaska where a majority of fish are hatchery raised.

Unless we begin really addressing the real reasons we are having low recruitment of striped bass in Chesapeake Bay, just more regulations on fishermen will have no positive impact. The spawning stock biomass we have right now in Chesapeake Bay is enough to produce the highest young of the year. Climate change and the warm water it produces, and the other environmental factors are not being addressed. All we are doing is restricting both the commercial and recreational harvests. Once again, I will point to weak fish, winter flounder and lobsters. We almost stopped the catch on those two fish species almost completely and there have been no positive gains that we can measure. With lobsters, we just let the fishery continue even though there hasn't been recruitment in southern New England lobster fishery in close to 20 years and the stocks continue to go down. Hatcheries might be the only way to rebuild the stocks. This will come down to money, and I don't hold out much hope. But I feel this may be the only way.



ASA Position Statement on Sector Separation

Revised April 2013

Harvest of marine fish stocks in federal waters is presently allocated between the commercial and recreational sectors at levels determined by the regional fishery management councils. The concept of subdividing the recreational allocation of some fish stocks into separate private angler and for-hire

components, known as sector separation, has recently been discussed for potential consideration by the Gulf of Mexico Fishery Management Council. Under the sector separation model, managers would assign quotas to the commercial sector, private boat anglers sector, and charter/for-hire sector. ASA is opposed sector separation because:

1. A fair process for allocation between sectors and schedules for revisiting allocation among sectors has not been developed by the Fishery Management Councils or the National Marine Fisheries Service, and as a result many outdated and inequitable allocations remain in place. Standard guidance for addressing allocation that is measurable and predictable is needed before any discussions of sector separation.
2. Sector separation will create imbalances in quota allocations between for-hire/charter boat fishing and private boat anglers and will lead to serious conflicts within the recreational fishing community, particularly with no process in place for fairly determining allocation.
3. Sector separation will likely result in disparate public seasons for most offshore recreational fishing. Private boat anglers will often be unable to pursue many species unless they pay a charter/for-hire vessel.
4. The socioeconomic impacts of sector separation have not been adequately addressed.

Until these concerns are fully addressed, ASA urges federal fishery managers to remove saltwater recreational sector separation from all management plan discussions. ASA believes that federal fishery managers should focus on more pressing concerns, such as addressing the significant underlying issues within federal fisheries data collection and developing a fair allocation process.

TAKE A VETERAN AND KID FISHING


